EvA95. To qualify for the grassroots section you need to be the owner of the horse that you are riding. You do not compete in Eventing as a professional or make a business out of eventing. In levels EvA 65 & EvA 80 you can be an EA, PCAV or HRCAV member and in the EvA95 you need to be an EA member and your horse needs to be registered with a competition license.

balance charged by FEI) This is included in your entry fee.

It is the responsibility of ALL Riders to ensure that they have correct registration of horse and rider at EA and /or FEI level as applicable.

In the EvA65 & EvA80 riders can be participant members and horses do not need to be registered.

PCV and HRCAV riders <u>cannot compete</u> higher than their assessed level. **PCV and HRCAV need to present their membership and assessment cards when picking up their numbers.** 

PCV and HRCAV riders can enter in any section in classes EvA65 & EvA80. PCV and HRCAV riders cannot enter in the EvA95 or above unless they are registered with EA and their horses are registered also. Riders also need to be registered with their respected clubs prior to entering.

It is ALL riders' responsibility to also check their eligibility for classes entered.

Any horse and rider needing a down grade due to lack of MER will be added to a wait list only. If the down graded rider does not get a start in the downgraded class they will NOT be eligible for ANY refunds of entry fee.

### **Cancellation POLICY-**

If the event is cancelled due to circumstance outside the control of the organisers an administration fee of 25% of all money paid by a rider will be retained by the organizers

### **REFUND POLICY**

If Riders scratch on or before the 26<sup>th</sup> of August 2016 they shall receive a FULL refund less a \$15.00 administration fee

If Riders scratch after the 26<sup>th</sup> of August 2016 they do not receive a refund of the entry fee, FEI swabbing fee or Victorian eventing levy for ANY reason whatsoever.

On provision of a medical or veterinary certificate the rider would only be entitled to a refund of the \$16 facility fee and any yard and bond fees paid.
