# Scratchings:

Please notify Julia Stewart 0406 072 589 (text preferred) as soon as possible. Vet or Medical certificates must be forwarded to the secretary within 7 days to receive a refund. 50% of entry fees will be retained to cover administration costs.

## **Secretary Office:**

Will be located in the Cafe. Cards do not need to be presented but you are required to check in prior to riding.

#### **Gear Check:**

Please report to gear check 20 mins prior to starting time.

#### Warm Up:

No lunging in the warm up arena, please only lunge in the designated area.

## **AOR (Amateur Owner Rider):**

If you are eligible, please make sure you have registered prior to the commencement of the competition.
