## **About Equestrian Victoria**

Equestrian Victoria is a not for profit organisation and is the recognised peak body of horse sports in Victoria with affiliations with relevant Government and Non-Government agencies at State level.

The primary objectives of Equestrian Victoria, in accordance with its Constitution are to:

- Encourage, develop, promote and control horse sports throughout the State of Victoria
- Establish and maintain, throughout Victoria, a uniform code of rules and regulations to govern horse sports under its jurisdiction
- Provide services and support to members, clubs, coaches, judges and administrators, which is second to none
- Encourage community health, welfare, physical education and research through horse sports
- Regulate, supervise, coordinate and promote Horse Sports activities, programs, competitions and events

- Appointment as tax agent for the entity
- BAS assistance, review & lodgement
- Preparation of monthly financial reports, departmentalised to report profit centres at various levels
- Quarterly Funds Statement or Statement of Cash Flow
- Projected monthly Profit and Loss Statement to be used to compare monthly performance to actual within Xero
- Projected monthly cash flow forecast to gain an understanding of the future trends in Bank Balances and cash position

- Provision of support and assistance to the entity's bookkeeper (EV utilises Xero Accounting Software and as such experience with Xero is required)
- Preparation of year end accounts for presentation at the organisation's annual general meeting and for audit by an independent auditor
- Specific advice, support and assistance as required
