Entry Requirements - waitlist/refunds	<p>Once again we are excited to continue a Grassroots section from EV 65 - EvA95. To qualify for the grassroots section you must be the owner of the horse that you are riding. You do not compete in Eventing as a professional or make a business out of eventing. You have not, nor plan to compete at 1* level or above</p> <p>In level EV 65 you may be an EA, PCV/PCA or HRCav member; in the EvA80 section you must be at least a participant EA member and in EvA95 and above you must be a competitor EA member and your horse must be registered with a current competition license. In EvA80 level, your horse is not required to be registered</p> <p>Enter - on line at www.nominate.com.au</p> <p>Entry fees include the WPNEC facility fee of \$16/ per horse/per night & the \$25 Eventing Levy</p> <p>Camping and stabling must be booked through the WPNEC website at http://wpnec.com.au/bookings/</p> <p>It is the responsibility of ALL Riders to ensure that they have correct registration of horse and rider at EA and /or FEI level as applicable.</p> <p>PCV and HRCav riders cannot compete higher than their assessed/grading level. PCV and HRCav need to present their membership and assessment/grading cards when picking up their numbers.</p> <p>PCV and HRCav riders can enter in any section of the EV65 class. PCV and HRCav riders cannot enter in the EvA80 classes or above unless they are also members of EA. Riders also need to be registered with their respective organisation prior to entering</p> <p>It is ALL riders' responsibility to also check their eligibility for classes entered.</p> <p>Any horse and rider needing to down grade due to lack of MERs will be added to a wait list only. If the down graded rider does not get a start in the downgraded class they will NOT be eligible for ANY refunds of entry fee.</p>
Cancellation and Refund Policies:	<p>If the event is cancelled due to circumstances outside the control of the organisers an administration fee of 25% of all money paid by a rider will be retained by the organizers</p> <p>If Riders scratch on or before the closing date they shall receive a FULL refund less a \$15.00 administration fee</p> <p>If Riders scratch after the closing date they do not receive a refund of the entry fee, or Victoria Eventing levy for ANY reason whatsoever.</p> <p>On provision of a medical or veterinary certificate the rider shall only be entitled to a refund of the facility fees and any yard and bond fees paid.</p>
