Squad member requirements:

- Applicants must be current financial members of EA and born in years 2004 onwards to be eligible to participate as a Squadette member.
- Cost is \$60 per training day inclusive of venue facility fees (yard for horse) and BBQ lunch. Weekend training on 8th & 9th July is \$120 for the two days. Each training day includes three riding sessions and other supplementary training/guest speakers that are timetabled.
- Each Squadette member commits to payment of 6th May, 27th May, 17th June and 8th&9th July training dates; with \$75 deposit paid on confirmation of place in April. Three (3) installments of \$75 will be invoiced to members at the beginning of May, June and July thereafter. Payments are non-refundable.
- The fifth Squad date of 29th and 30th July will be training on Saturday and a Squad Show on Sunday. This is an **optional** Squadette weekend for riders.
- There is a December training day set and this will be a Christmas breakup. This is also an **optional** Squadette training day for riders.

Please note: The program budget is set to cover costs associated with coaches, guest speakers, catering, venue costs etc. Jumping Vic is committed to maintaining an affordable program for riders, however costs to Jumping Vic are not discounted if riders do not attend and therefore the program of four training dates requires the financial commitment of the Squadette rider.

*Camping is an additional cost as required, which can be booked directly with Werribee Park

Please note: Riders who do not return the signed conditions will not be eligible for selection to a squad.

1. I am a current financial member of EA and will ensure my membership is current at the commencement of training weekends
2. As a representative of the Jumping Victoria Squadettes, I acknowledge as a Squadettes member I am also an ambassador for Jumping Victoria and any sponsors associated with the Squadettes program. I will conduct myself in a positive and acceptable manner at all times. I will endeavour to show good sportsmanship and team spirit at all times.
4. As this is a Sport training program, appropriate standards must be set to protect the younger members of the group - No underage consumption of alcohol will be permitted at any time and there will be no consumption of alcohol by squad members of the legal age at any Squad meals or guest speaker sessions.
5. I accept I am committed to financially pay a minimum amount of \$240 for the training costs of this squadette program for 6th May, 27th May, 17th June and 8th & 9th July regardless of attendance to these training days.
6. I will endeavour to participate in all organised activities at the Squadettes training days.
7. Riders 16 years and under must have adult supervision while at the training venue. Parents accept they are still responsible at all times for the conduct of their children.
