 & ELECTIONBUDDY VOTING PORTAL on Tuesday 16 November 2021.
- 2. Any notice of motion submitted must relate to a matter which is expressed in the Constitution to be a right or power of the Members in General Meeting. Further, where the subject of a notice of motion relates to a matter which is not expressly stated in the Constitution or the Association Incorporation Reform Act 2012 (Vic) to be a right or power of the Members at a General Meeting, it will not be considered a valid notice of motion and will not be included as special business at a General Meeting.
- 3. The notice of motion must be completed using the form provided as attached. To be included in the agenda, any notice of motion must be received in accordance with the Equestrian Victoria Constitution using the attached form.
- 4. The notice must:
 - a. be in writing;
 - b. set out the wording of the proposed resolution; and
 - c. be signed by the members proposing to move the resolution
- The properly completed notice of motion must be received by the Equestrian Victoria CEO no later than 7.30pm Sunday, 17 October 2021 being no less than 30 days prior to the Annual General Meeting.

Consistent with clause 23.1 (a) formal notice of the annual general meeting details and other information will be distributed in accordance with the Equestrian Victoria Constitution at least 21 days prior to the meeting date.
