



2025-26 Equestrian Victoria Memberships

Dear EV Member,

We are writing to advise that Equestrian Victoria memberships for the 2025–26 financial year are now open.

We acknowledge the delay in opening memberships this year and thank you for your patience.

This delay was necessary due to ongoing negotiations with Equestrian Australia regarding the scale of their proposed fee increases. **EV and other States proposed an increase of only 10% to EA which was rejected**. As a result, we have worked hard to minimise the financial impact on our members by **not increasing EV Membership levy in any categories** and only passing on the **EA increases which, we do not support**.

Understanding Your Membership

When you join Equestrian Victoria, you also become a member of Equestrian Australia.

The fees received this financial year are distributed across four key areas, being:

- Equestrian Australia Administration Levy
- Equestrian Australia Insurance Levy
- Equestrian Australia IT Levy
- Equestrian Victoria Membership Levy

Membership Categories

Equestrian Victoria offers membership options to suit every equestrian, from grassroots to elite, for both riders and non-riding supporters:

Riding Memberships:

- **Competitor** (Senior & Junior) Suitable for those competing in official classes in Dressage, Vaulting, Driving, Interschool, Jumping 105cm+, or Eventing 95cm+
- **Showhorse** for members with full competitor rights for all EV/EA Show Horse events, and Participant level membership rights in all other disciplines
- Participant for those that participate in and contribute to grassroots equestrian sports activities.
- **Recreational** covers insurance 24/7, allowing members to join now, with the opportunity to upgrade to participant or competitor at a later date

Non-Riding Memberships:

- **Supporter Official** for those that contribute to the competition environment but do not participate in competitions as riders. Suitable for all accredited EA officials, judges, stewards, technical delegates
- Supporter Other For supporters such as owners, breeders, volunteers offering 24/7 PI & PL insurance

2025-2026 Membership Fee Increases

We understand that the increases this year are the most significant in our history, so for complete transparency we are also providing a detailed summary below of exactly where fee increases have occurred.

It is important to note that, under the current EA Constitution, EV and other States must adopt the national fees and levies set by Equestrian Australia.

In consideration of the large increases from Equestrian Australia, *Equestrian Victoria has chosen not to raise any of our Victorian fee components*.
