## Qualifying show for Barastoc and NSW Southern Cross Spectacular

The event is to be run under EA Rules insofar as they are applicable to this event and shall include any other rules formulated by the organising committee. We strongly recommend that all competitors obtain a copy of the relevant EA Rules through EV website vic.equestrian.org.au This show will also be run in accordance with Government Regulations in relation to COVID-19. These restrictions will be communicated closer to the event.

It is recommended that competitors print a copy of their entry form and bring this with them to the show.

Entries Open; 1<sup>st</sup> September 2020. Entries Close; 25 September 2020

Entries via Nominate: No late entries will be accepted.

Qualifying: This event will be a qualifier for the Victorian Barastoc Horse Of The Year 2021.

It will also be a qualifier for the 2021 NSW Southern Cross Spectacular. Performances may also be considered for some 2021 Royal Shows.

Entry Fee is \$10 per class, plus \$16 WPNEC facility fee per horse.

This show is proudly supported by both Barastoc and United Fuel.

**Refund Policy:** Entry fees will not be refunded after the close of entries. Scratching prior to the close of entries will incur a \$20 administration fee. No refunds/scratching or substituting after entries close.

**Registration of Horses:** All horses must be EA registered.

**Insurance & Membership:** All competitors must hold a current EA Membership, either Showhorse, Participant or Competitor level.



**Owner Rider:** Horses must be the bona fide property of the primary owner or the owner's immediate family (wife, husband, mother, father, sister or brother of competitor) Horses must be exhibited by the bona fide owner in all other 2020 Spring Show classes with the exception of Children's, Rider and Leading Rein classes.

Horses owned in partnership other than with immediate family are not eligible to compete. Leased horses are not eligible.

Horses must be registered with EA. Exhibitors and owners must be current financial Competitor or Participant members of EA.

**Childs:** Open to all riders under 18 years as at 1 January 2020 except for classes 12hh and under where riders must be under 14 years of age.

**Newcomers:** A horse that has not competed under saddle (with the exception of racing) in any state or territory prior to 1 January 2020. Must be shown in a snaffle. (EA National Showhorse rules)

**Intermediate:** A horse which has not been placed first, second or third under saddle at a capital city Royal Show.

**Height Certificates:** All horses must carry a current height certificate. Measuring will be available at the show on Sunday 4 October. Times will be advertised. However no class will be held for competitors who have not obtained a measuring certificate.

**Event Operation Fee:** All competitors must pay the compulsory, non-refundable event fee of \$10 per exhibitor at the time of entry. This fee will encompass compulsory medical services, security and event office administration during the event.
